Organizational reform and changes in the Executive Officers

AGC Asahi Glass Co., Ltd.

Following the recommendation of the Nominating Committee, and approval at the meeting of the Board of Directors held today, AGC (Asahi Glass Co., Ltd.) hereby announces the following changes in the assignments of Executive Officers, as well as organizational reform and other personnel changes.

1. Organizational Reform that will be made as of January 1, 2016

(1) Creation of Corporate Planning Division:

The Office of the President and the Corporate Communications & Investor Relations Office will be integrated into a new organization called the Corporate Planning Division. The Corporate Planning Division is designed to strengthen the strategy planning function in the Office of the President and promote more strategic top management communication with internal and external stakeholders. The Strategy & Planning Office and the Corporate Communications & Investor Relations Office will belong to this new division.

(2) Organizational changes in Human Resources & Administration Office, CSR Office, and MONOZUKURI & Personal Growth Enhancement Office:

The Human Resources Division will be newly created for the integrated management of HR related functions from hiring to human resources development, which have been managed under the Human Resources & Administration Office and the MONOZUKURI & Personal Growth Enhancement Office.

The General Affairs Division will be newly created and the general affairs function, which has been managed under the Human Resources & Administration Office, and the CSR function, which has been managed under the CSR Office, will be unified under the new organization. The CSR Office and the Environment, Safety and Quality Office will belong to the General Affairs Division.

The MONOZUKURI & Personal Growth Enhancement Office will be renamed the Productivity Innovation Division, and its employee training function will be transferred to the Human Resources Division.

(3) Organizational changes in the Technology General Division:

The Research Center, the Production Technology Center and the Engineering Center under the Technology General Division will be reorganized. Specifically, the Innovative Technology Research Center will be created for the generation of innovative fundamental technologies and the support of product development through state-of-art information technology, analysis technology and other fundamental technologies shared across the AGC Group. The New Product R&D Center will be created for the development of new products and the provision of solutions to technological problems in existing products. The Production Technology Division will be created for the implementation and management of capital investments and the development and improvement of production technologies.

(4) Organizational changes in the technology development structure of the Glass Company:

The Technology General Division under the Glass Company will be abolished and its technology development function will be transferred to and reorganized into the technology development organizations under the Building & Industrial General Division and the Automotive General Division.

(5) Other:

Excluding those mentioned above, all the Corporate Offices under the corporate & back office functions and Service Centers that provide shared serves will be changed to "Division" from the current organization title.

2. Changes in Job Titles and Reporting Lines (effective from January 1, 2016)

The Senior Executive Officers in charge of Overall Business Management (Technology and Business Development) and Overall Business Management (Finance) will become Chief Finance Officer (CFO) and Chief Technology Officer (CTO) respectively and will supervise the following divisions.

CFO: The Corporate Planning Division, the General Affairs Division, the Legal Division, the Human Resources Division, the Finance & Control Division, the Purchase & Logistics Division, and the Information Systems Division

CTO: The Technology General Division and the Business Development Division

CEO will supervise the Internal Audit Division and the Productivity Innovation Division.
