- ✓ Environment, Safety and Quality Office will be split off from General Affairs Division to form an independent division called Environment, Safety and Quality Division.
- (3) Organization change of technology sections:
 Intellectual Property Division will be split off from Technology General Division to form an independent division.
- (4) Changes in the scope of responsibilities of CFO and CTO:
 Along with the above organization changes, the scope of the responsibilities of CFO and CTO will be changed as follows:
 - CFO: Corporate Planning General Div., General Affairs Div., Corporate Communications & Investor Relations Div., Legal Div., Human Resources Div., Finance & Control Div., Purchase & Logistics Div., Information Systems Div.
 - CTO: Technology General Div., Productivity Innovation Div., Business Development Div., Intellectual Property Div., Environment, Safety and Quality Div.

CEO will continue to supervise the Internal Audit Div.

(5) Organization change of Electronics Company and Applied Glass Materials General Division:
The Company will incorporate Applied Glass Materials General Division, which is operated as an independent Strategic Business Unit, into Electronics Company.
